

Daily Market Summary

EQUITIES MARKET

NGX ASI DEPRECIATES MARGINALLY BY 0.02%

Equities market closed the day's trading session in red zone as the NGX All Share Index and Market Capitalisation depreciated by 0.02% to close at 46,766.16 and ₦25.21 trillion respectively. The Year-to-Date (YtD) and the Quarter-to-Date (QtD) returns stand at 9.48% and -0.42%, while the Month-to-Date (MtD) and Week-to-Date returns stand at -0.42% and -0.16% respectively.

NGX Sector Indices: Of all the Industries on the NGX within our coverage, 4 sectors advanced in points while 2 sectors declined. The NGX sector indices that advanced in points were NGX INSURANCE (+0.48%), NGX OIL & GAS (+0.20%), NGX BANKING (+0.15%) and NGX PREMIUM (+0.07%) while the sectors that declined in points were NGX 30 (-0.07%) and NGX CONSUMER GOODS (-0.22%).

The market breadth (gainers/losers) of 0.89x for the day indicates that the number of sellers outpaced the number of buyers in the market today. At the end of the day's trading, 16 stocks advanced as 18 stocks declined; REGALINS (+10.00%), LIVESTOCK (+9.59%) and MULTIVERSE (+9.52%) led the gainers chart while NPFMCRFBK (-9.78%), RTBRISCOE (-8.93%) and PRESTIGE (-8.16%) led the losers chart for the day.

The day's trading activities by volume was led by FIDELITYBK (81.75million), TRANSCORP (30.72million) and GTCO (15.49million) while the activity by value was led by MTNN (₦0.38billion), GTCO (₦0.35billion) and FIDELITYBK (₦0.28billion).

Fig. 1: Top Traded Stocks by Volume

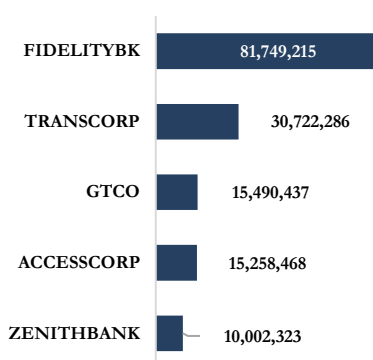


Fig. 2: Top Traded Stocks by Value

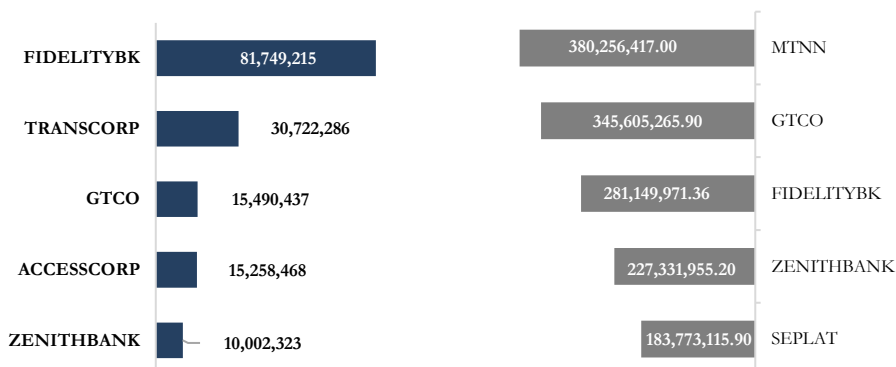
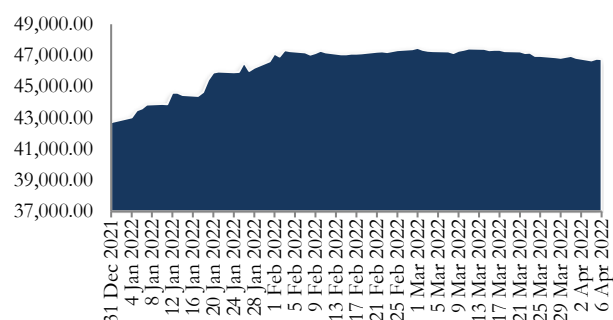


Fig. 3: NGX-ASI (Year-to-Date)



FIXED INCOME AND FX MARKET

Treasury Bills Market

In the treasury bills markets, the average yield increased by 9bps as it closed at 3.79% today (vs. 3.70% average market yield of last trading session). At the end of the trading session today, the 91 Days, 182 Days and 364 Days bills closed at 3.16% (0.19%), 3.72% (0.04%), and 4.50% (0.04%) respectively.

Bond Market

In the bond market, the average market yield decreased by an average of 3bps as it closed at 9.84% as against 9.84% of the previous session. The result for the 27-Apr-2023, 14-Mar-2024, 22-Jan-2026, 23-Feb-2028, 23-Jul-2030, 24-Jul-2045 and 27-Mar-2050 bonds traded are 4.91% (-0.03%), 7.32% (0.00%), 10.14% (0.00%), 10.66% (0.00%), 11.19% (0.00%), 11.80% (0.00%) and 12.85% (0.00%) respectively.

Foreign Exchange Market

At the Foreign Exchange market, Naira depreciated by 14 kobo against dollar as it closed at ₦416.03/\$ today (vs. ₦415.89/\$ it closed in the previous trading session). The Open-Buy-Back (OBB) and Overnight (O/N) rate increased by an average of 225 bps, closing at 8.00% and 8.50% respectively.
