

MARKET CAPITALISATION HITS ₦21.52 TRILLION AS NSE ASI RECORDS A GAIN OF 2.18% ON THE FIRST TRADING DAY OF THE YEAR

Equities market closed the day's trading session in green zone as the NSE All Share Index and Market Capitalisation appreciated by 2.18% to close at 41,147.39 and ₦21.52 trillion respectively. The Year-to-Date (YtD) and the Quarter-to-Date (QtD) returns stand at 2.18% and 2.18%, while the Month-to-Date (MtD) and Week-to-Date returns stand at 2.18% and 2.18% respectively.

NSE Sector Indices: Of all the Industries on the NSE within our coverage, all 6 sectors advanced in points. The NSE sector indices that advanced in points were NSE INSURANCE (+4.39%), NSE BANKING (+3.68%), NSE 30 (+2.92%), NSE CONSUMER GOODS (+1.41%), NSE PREMIUM (+1.05%) and NSE OIL & GAS (+0.09%).

The market breadth (gainers/losers) of 16.00x for the day indicates that the number of buyers outpaced the number of sellers in the market today. At the end of the day's trading, 32 stocks advanced as 2 stocks declined; HONYFLOUR (+10.00%), SOVRENINS (+10.00%) and TRANSCORP (+10.00%) led the gainers chart while FCMB (-6.01%) and CAVERTON (-3.41%) led the losers chart for the day.

The day's trading activities by volume was led by AIICO (87.52million), FCMB (19.67million) and TRANSCORP (12.78million) while the activity by value was led by ZENITHBANK (₦0.23billion), WAPCO (₦0.22billion) and GUARANTY (₦0.19billion).

Outlook: Market capitalisation hits ₦21.52 trillion as NSE ASI records a gain of 2.18% on the first trading day of the year. Optimisms persist that the bulls will recover the market in the coming days. We therefore advise our clients not to engage in panic selling as we expect equity market to maintain positive growth due to the expectation of dividend payment in early 2021 and lower yields in fixed income market.

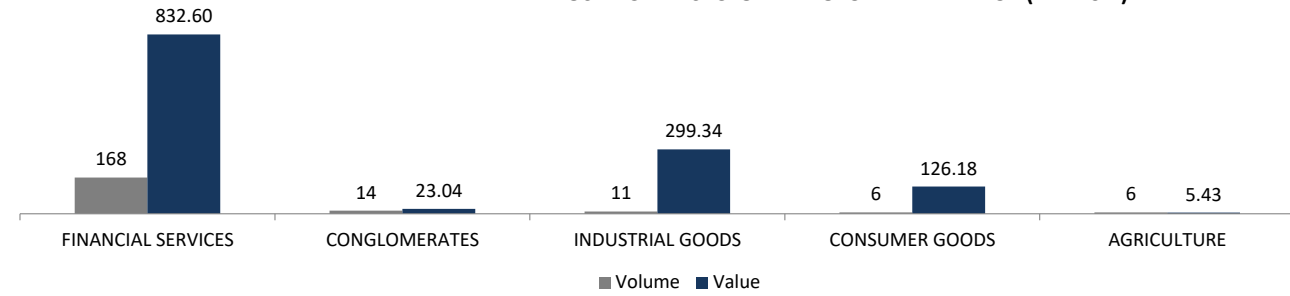

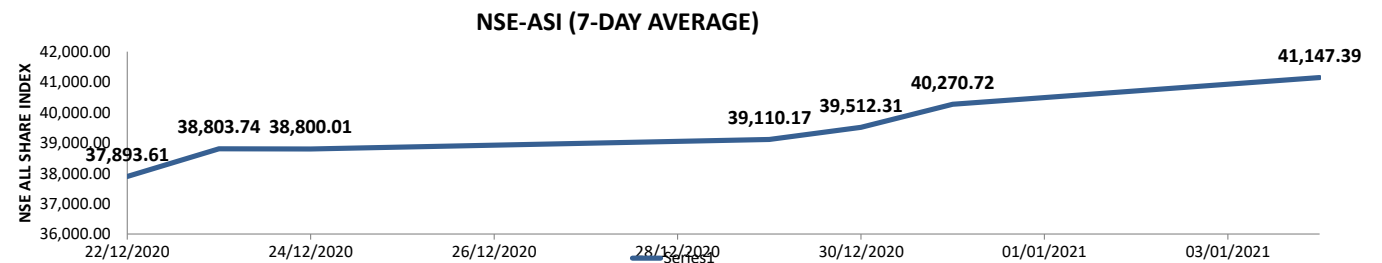
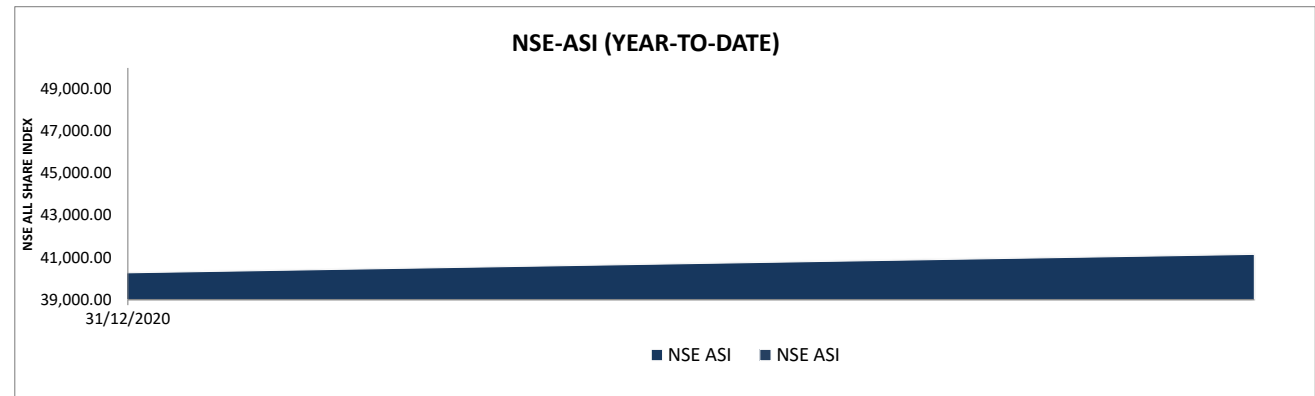
FIVE MOST ACTIVE SECTOR BY VOLUME AND VALUE ('million')

FIXED INCOME REPORT AS AT DECEMBER 31, 2020

Treasury Bills Market:

In the treasury bills markets, the average yield decreased by 1bps as it closed at 0.45% today (vs. 0.47% average market yield of last trading session). At the end of the trading session today, the 11-Mar-21, 10-Jun-21 and 28-Oct-21 bills closed at 0.34% (0.00%), 0.37% (-0.04%), and 0.65% (0.00%) respectively.

FGN Bond Market:

In the bond market, the average market yield decreased by an average of 192bps as it closed at 4.95% as against 5.19% of the previous session. The result for the 14-Nov-2021, 27-Apr-2023, 23-Mar-2025, 17-Mar-2027, 20-Nov-2029, 18-Mar-2036 and 26-Apr-2049 bonds traded are 1.38% (-0.01%), 3.54% (-0.01%), 5.44% (-0.01%), 6.50% (-0.64%), 7.12% (0.03%), 7.80% (0.00%) and 7.38% (-1.28%) respectively.

Foreign Exchange Market:

At the FX Market (CBN Official Window), Naira remains unchanged, closing at ₦379.00/\$ today compared to the ₦379.00/\$ it traded in the previous trading session. On Investors and Exporters Window, Naira depreciated by ₦16.25 kobo against dollar as it closed at ₦410.25/\$ today (vs. ₦394.00/\$ it closed in the previous trading session).

Money Market:

In the Money Market today, the REPO rate increased by an average of 13bps to tighten liquidity. At the end of the trading session, the call, 1M, 2M, 3M rate closed at 1.00% (0.50%), 1.00% (0.00%), 3.00% (0.00%) and 6.00% (0.00%) respectively. However, Open-Buy-Back (OBB) and Overnight (O/N) rate increased by an average of 21bps, closing at 0.50% and 0.83% respectively.
