EQUITIES MARKET CONTINUES TO DECLINE AS NGX ASI DEPRECIATES FURTHER BY 0.06% TODAY

Equities market closed the day's trading session in red zone as the NGX All Share Index and Market Capitalisation depreciated by 0.06% to close at 51,556.54 and ₦27.79 trillion respectively. The Year-to-Date (YtD) and the Quarter-to-Date (QtD) returns stand at 20.69% and -0.50%, while the Month-to-Date (MtD) and Week-to-Date returns stand at -0.50% and -0.53% respectively.

NGX Sector Indices: Of all the Industries on the NGX within our coverage, 1 sector advanced in points while 5 sectors declined. The NGX sector that advanced in points was NGX PREMIUM (+0.07%) while the sectors that declined in points were NGX CONSUMER GOODS (-0.03%), NGX 30 (-0.09%), NGX OIL & GAS (-0.16%), NGX BANKING (-0.60%) and NGX INSURANCE (-1.36%).

The market breadth (gainers/losers) of 1.06x for the day indicates that the number of buyers outpaced the number of sellers in the market today. At the end of the day's trading, 17 stocks advanced as 16 stocks declined; ACADEMY (+9.79%), CHIPLC (+8.70%) and JAPAUFGOLD (+7.41%) led the gainers chart while NEM (-10.00%), CHAMPION (-10.00%) and UBN (-9.76%) led the losers chart for the day.

The day's trading activities by volume was led by TRANSCORP (15.55million), GTCO (13.11million) and UPDC (11.97million) while the activity by value was led by GTCO (₦0.27billion), AIRTELAFRI (₦0.21billion) and ZENITHBANK (₦0.16billion).

Fig. 1: Top Traded Stocks by Volume

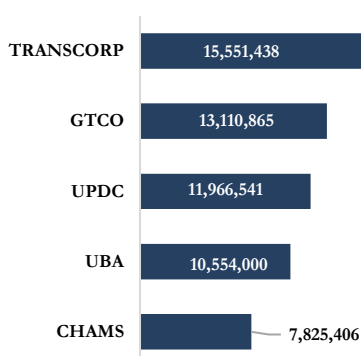


Fig. 2: Top Traded Stocks by Value (₦)

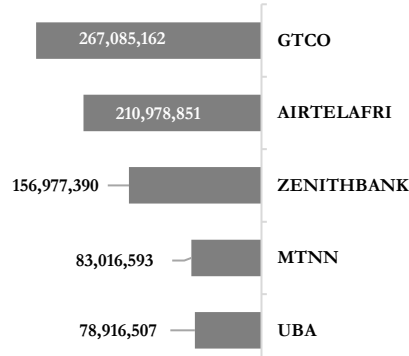
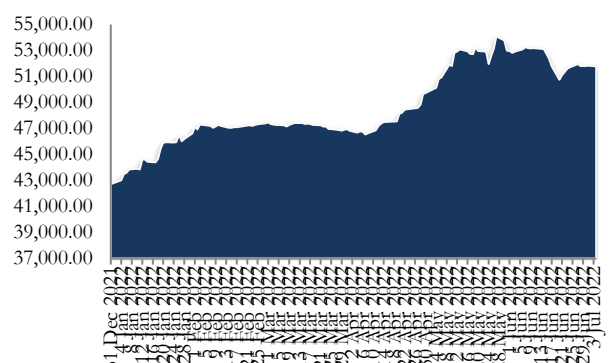


Fig. 3: NGX-ASI (Year-to-Date)



FIXED INCOME AND FX MARKET

Treasury Bills Market

In the treasury bills markets, the average yield increased by 93bps as it closed at 6.33% today (vs. 5.39% average market yield of last trading session). At the end of the trading session today, the 91 Days, 182 Days and 364 Days bills closed at 5.18% (0.92%), 6.26% (1.03%), and 7.54% (0.85%) respectively.

Bond Market

In the bond market, the average market yield decreased by an average of 13bps as it closed at 10.31% as against 10.33% of the previous session. The result for the 27-Apr-2023, 14-Mar-2024, 22-Jan-2026, 23-Feb-2028, 23-Jul-2030, 24-Jul-2045 and 27-Mar-2050 bonds traded are 6.29% (-0.09%), 8.14% (0.09%), 10.24% (0.00%), 10.88% (0.05%), 11.25% (0.00%), 12.37% (0.00%) and 12.98% (-0.17%) respectively.

Foreign Exchange Market

At the Foreign Exchange market, Naira depreciated by ₦1.25 kobo against dollar as it closed at ₦426.38/\$ today (vs. ₦425.13/\$ it closed in the previous trading session). The Open-Buy-Back (OBB) and Overnight (O/N) rate decreased by an average of 9 bps, closing at 13.83% and 14.00% respectively.
