

## EQUITIES MARKET

### INVESTORS GAIN ₦130.21 BILLION AS NGX ASI CONTINUES TO APPRECIATE

Equities market closed the day's trading session in green zone as the NGX All Share Index and Market Capitalisation appreciated by 0.47% to close at 51,618.73 and ₦27.83 trillion respectively. The Year-to-Date (YtD) and the Quarter-to-Date (QtD) returns stand at 20.84% and 9.91% respectively, while the Month-to-Date (MtD) and Week-to-Date returns stand at -2.59% and -0.31% respectively.

**NGX Sector Indices:** Of all the Industries on the NGX within our coverage, 5 sectors advanced in points while 1 sector declined. The NGX sector indices that advanced in points were NGX PREMIUM (+1.61%), NGX 30 (+0.75%), NGX INSURANCE (+0.73%), NGX OIL & GAS (+0.53%) and NGX BANKING (+0.15%) while the sectors that declined in points were NGX CONSUMER GOODS (-0.34%).

The market breadth (gainers/losers) of 0.82x for the day indicates that the number of sellers outpaced the number of buyers in the market today. At the end of the day's trading, 19 stocks advanced as 23 stocks declined; FBNH (+9.78%), FTNCOCOA (+9.38%) and CHIPLC (+8.06%) led the gainers chart while ELLAHLAKES (-10.00%), ACADEMY (-10.00%) and PRESCO (-9.84%) led the losers chart for the day.

The day's trading activities by volume was led by MBENEFIT (40.13million), OANDO (28.52million) and FCMB (24.45million) while the activity by value was led by PRESCO (₦0.38billion), MTNN (₦0.37billion) and AIRTELAFRI (₦0.30billion).

Fig. 1: Top Traded Stocks by Volume

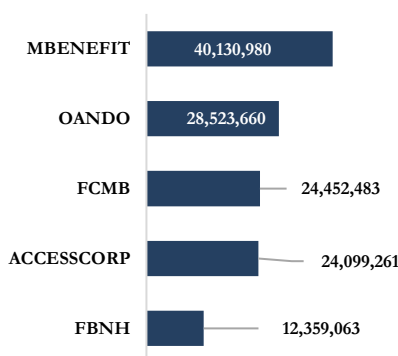


Fig. 2: Top Traded Stocks by Value (₦)

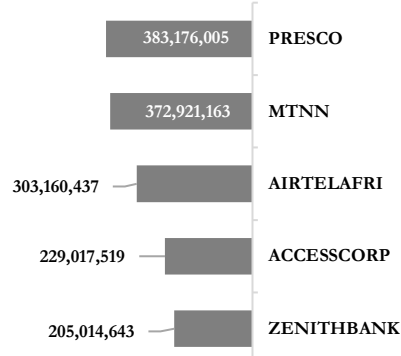
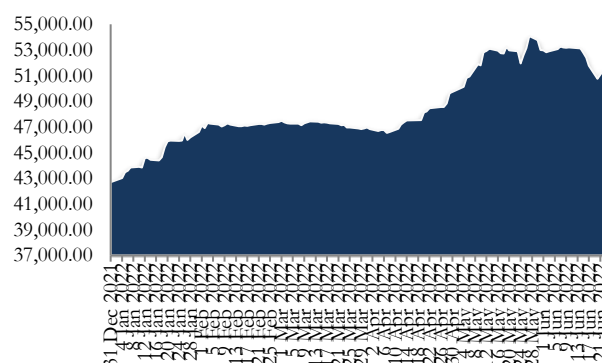


Fig. 3: NGX-ASI (Year-to-Date)



## FIXED INCOME AND FX MARKET

## Treasury Bills Market

In the treasury bills markets, the average yield decreased by 11bps as it closed at 5.26% today (vs. 5.37% average market yield of last trading session). At the end of the trading session today, the 91 Days, 182 Days and 364 Days bills closed at 4.07% (-0.26%), 5.13% (0.00%), and 6.58% (-0.06%) respectively.

## Bond Market

In the bond market, the average market yield decreased by an average of 17bps as it closed at 10.13% as against 10.15% of the previous session. The result for the 27-Apr-2023, 14-Mar-2024, 22-Jan-2026, 23-Feb-2028, 23-Jul-2030, 24-Jul-2045 and 27-Mar-2050 bonds traded are 6.03% (0.00%), 7.97% (-0.03%), 10.14% (-0.20%), 10.86% (0.06%), 11.09% (0.00%), 11.83% (0.00%) and 12.98% (0.00%) respectively.

## Foreign Exchange Market

At the Foreign Exchange market, Naira depreciated by 6 kobo against dollar as it closed at ₦417.73/\$ today (vs. ₦417.67/\$ it closed in the previous trading session). The Open-Buy-Back (OBB) and Overnight (O/N) rate decreased by an average of 15 bps, closing at 13.83% and 14.00% respectively.
