

Daily Market Summary

EQUITIES MARKET

NGX ASI SURGES UP BY 1.99%.

Equities market closed the day's trading session in green zone as the NGX All Share Index and Market Capitalisation appreciated by 1.99% to close at 52,838.45 and ₦28.49 trillion respectively. The Year-to-Date (YtD) and the Quarter-to-Date (QtD) returns stand at 23.70% and 12.50%, while the Month-to-Date (MtD) and Week-to-Date returns stand at 6.45% and 3.74% respectively.

NGX Sector Indices: All the six (6) sectors on the NGX within our coverage advanced in points. The NGX sector indices that advanced in points were NGX PREMIUM (+4.54%), NGX 30 (+2.94%), NGX CONSUMER GOODS (+1.48%), NGX INSURANCE (+0.94%), NGX OIL & GAS (+0.10%) and NGX BANKING (+0.03%).

The market breadth (gainers/losers) of 1.59x for the day indicates that demand outpaced supply in the market today. At the end of the day's trading, 43 stocks advanced as 27 stocks declined; CWG (+10.00%), OKOMUOIL (+10.00%) and CHAMPION (+9.93%) led the gainers chart while IKEJAHOTEL (-10.00%), BUAFOODS (-10.00%) and ETERNA (-9.92%) led the losers chart for the day.

The day's trading activities by volume was led by JAIZBANK (40.44million), TRANSCORP (35.37million) and INTBREW (25.35million) while the activity by value was led by MTNN (₦1.29billion), DANGCEM (₦1.13billion) and GTCO (₦0.45billion).

Fig. 1: Top Traded Stocks by Volume

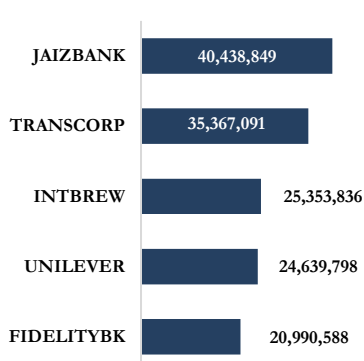


Fig. 2: Top Traded Stocks by Value (₦)

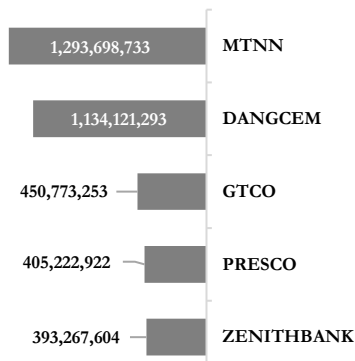
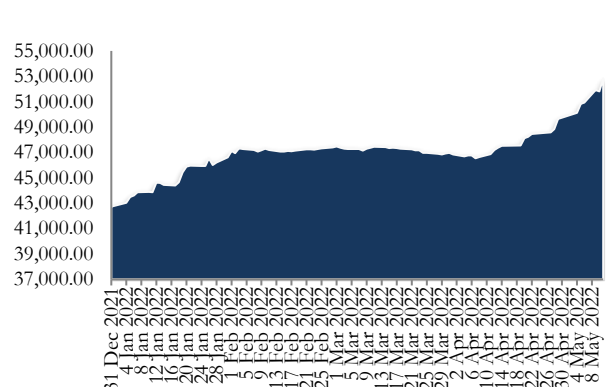


Fig. 3: NGX-ASI (Year-to-Date)



FIXED INCOME AND FX MARKET

Treasury Bills Market

In the treasury bills markets, the average yield increased by 10bps as it closed at 4.17% today (vs. 4.07% average market yield of last trading session). At the end of the trading session today, the 91 Days, 182 Days and 364 Days bills closed at 3.50% (0.08%), 3.93% (0.07%), and 5.07% (0.14%) respectively.

Bond Market

In the bond market, the average market yield decreased by an average of 2bps as it closed at 10.08% as against 10.08% of the previous session. The result for the 27-Apr-2023, 14-Mar-2024, 22-Jan-2026, 23-Feb-2028, 23-Jul-2030, 24-Jul-2045 and 27-Mar-2050 bonds traded are 4.69% (0.00%), 7.73% (-0.01%), 10.49% (-0.01%), 11.28% (0.00%), 11.72% (0.00%), 11.82% (0.00%) and 12.83% (0.00%) respectively.

Foreign Exchange Market

At the Foreign Exchange market, Naira appreciated by 45 kobo against dollar as it closed at ₦415.92/\$ today (vs. ₦416.37/\$ it closed in the previous trading session). The Open-Buy-Back (OBB) and Overnight (O/N) rate increased by an average of 123 bps, closing at 5.75% and 6.38% respectively.
